Attention Property Owner:

You are in violation of Article 304 of Title 28 of the NYC Administrative Code and section 103-02 of Title 1 of the Rules of the City of New York for not filing a category 1 test report for each elevator device at the premises for the filing period January 1, 2020 to December 31, 2020.

You are subject to civil penalties of \$3,000.00 per elevator and a new category 1 test report for the current filing period is required.

**Instructions to Pay or Waive Penalty**

- Submit **payment** in the DOB NOW self-service online portal for the failure to file civil penalties of \$3,000.00 per elevator. The violation will not be dismissed unless an accepted current category 1 test report has been submitted by a licensed professional in DOB NOW; or,
- Submit a **civil penalty waiver request** in the DOB NOW self-service online portal and upload any required supporting documentation. See 1 RCNY §103-02 for waiver reasons.

**How to use DOB NOW:**

Use an eFiling account to log into DOB NOW at [www.nyc.gov/dobnow](http://www.nyc.gov/dobnow). If you need to create an eFiling account, visit [www.nyc.gov/efilingtips](http://www.nyc.gov/efilingtips). Once logged in, select the **DOB NOW: Safety** module and then **Violations**. From the dashboard select **+Violations Payments** or **+Civil Penalty Waiver**.

**Payments:**

All payments are made in DOB NOW and can be paid by eCheck, credit card, PayPal, or Venmo. There is a 2% surcharge for credit card, PayPal, and Venmo payments. Payments made by eCheck may take up to 10 business days to process. **In-person and mail-in payments will not be accepted.**
