Federal Subscriber Line and Access Recovery**Charges**

On or after July 1, 2025, Federal Subscriber Line Charge (SLC) and Access Recovery Charge (ARC) rates may change on primary and additional phone lines. The SLC helps pay for the cost of providing and maintaining the local phone network. The ARC may be included in the SLC or may appear as a separate line item on the bill, and recovers part of the access rates charged between carriers to carry telecommunications traffic.

Business Services Change

On or after July 1, 2025, subject to review by the Public Service Commission where applicable, Integrated Services Digital Network (ISDN) Primary Service Term & Volume II Package Plan 1 and 3-year term plans and all PRI Plus term plan agreements will no longer be offered to new customers. Existing customers may continue their Integrated Services Digital Network (ISDN) Primary PRI service until the end of the contract term. At the end of all Integrated Services Digital Network (ISDN) Primary Service contracts the rates will revert to the prevailing Month-to-Month rates unless another qualifying term plan is selected.

If any of these changes apply to you, you can discontinue the service(s) affected before the change becomes effective. However, if you have a term commitment for the affected service(s), please consult your contract or Verizon's Product Guide for further information on termination of such commitment.

Customer Notices**Your Choices to Limit Use and Sharing of Information for Marketing**

You have choices about Verizon's use and sharing of certain information for the purpose of marketing new services to you. Verizon offers a full range of services, such as television, telematics, high-speed internet, video, and local and long distance services.

Unless you notify us as explained below, we may use or share your information beginning 30 days after the first time we notify you of this policy. Customer Proprietary Network Information (CPNI) is information available to us solely by virtue of our relationship with you that relates to the type, quantity, destination, technical configuration, location, and amount of use of the telecommunications and interconnected VoIP services you purchase from us, as well as related billing information.

We may use and share your CPNI among our affiliates and agents to offer you services that are different from the services you currently purchase from us. If you don't want us to use or share your CPNI with our affiliates and agents for this purpose, let us know by calling us any time at 1.866.483.9700.

- Information about Your Credit

Information about your credit includes your credit score, the information found in your consumer reports and your account

history with us. We may share this information among the Verizon family of companies for the purpose of marketing new services to you. If you don't want us to share this information among the Verizon family of companies for the purpose of marketing new services to you, let us know by calling us any time at 1.844.366.2879.

Electronic Fund Transfer (EFT)

Paying by check authorizes us to process your check or use the check information for a one-time EFT from your bank account. Verizon may retain this information to send you electronic refunds or enable your future electronic payments to us. If you do not want Verizon to retain your bank information, call 1.888.500.5358.

Late Payment Charges

Restatement of Charges
