Scope of Work:

- 1) Evacuate all existing refrigerant from unit.
- 2) Remove and Cart away existing air handler servicing basement.
- 3) Remove and Cart away existing condenser servicing basement. Disconnect hot water supply from coil.
- 4) Remove and Cart away existing copper lines.
- 5) Furnish and Install 1 new American Standard 13 Seer condenser.
- 6) Furnish and Install 1 new indoor evaporator complete with hot water coil.
- 7) Furnish and Install copper refrigerant lines from indoor evaporator to outdoor condenser.
- 8) Charge system with proper levels of refrigerant
- 9) Pull Vacuum
- 10) Start up and Run System
- 11) Proposal Pricing: \$7,600.00

The agreement does not include responsibility for system design deficiencies, such as, but not limited to poor air distribution, water flow imbalances, etc. It does not include responsibility for system equipment and component obsolete electrical flake failures and equipment beyond it serviceable life.
5. Customer is responsible of the structural integrity of all beams, lentils, supports, roofing and the like. It is understood that customer has the authorization from the building owner to make said penetrations.
6. Customer is responsible for any and all electoral work, parts, or components required to render the A.C system operable.
7. Sheetrock, demolition, carpentry, electrical, roofing, masonry, plumbing, gas lines, stem lines, refrigeration lines and/or any general construction that is beyond the scope of our work and is not part of this proposal, is the responsibility of the customer.
8. All equipment specified in this proposal shall remain in the property of Mechanical Installation Corp. until paid in full.
9.
