**WITNESSETH**, that the party of the first part, in consideration of Ten Dollars and other valuable consideration paid by the party of the second part, does hereby grant and release unto the party of the second part, the heirs or successors and assigns of the party of the second part forever,

**ALL** that certain plot, piece or parcel of land, with the buildings and improvements thereon erected, situate, lying and being in the

Borough of Manhattan, City, County and State of New York, bounded and described as follow:

BEGINNING at a point on the northerly side of 71st Street, distant 125 feet westerly from the northwesterly corner of 71st Street and 11th Avenue, now called West End Avenue;

THENCE Westerly and along said northerly side of 71st Street, 16 feet;

THENCE Northerly and parallel with West End Avenue and part of the way through a party wall, 102 feet 2 inches to the center line of the block between 71st and 72nd Streets;

THENCE Easterly along said center line of the block, 16 feet;

THENCE Southerly and again parallel with West End Avenue, 102 feet 2 inches to the northerly side of 71st Street at the point or place of BEGINNING.




