The Minimum Payment Due is generally applied first to fees, interest and principal in the balance with the lowest APR, then to fees, interest and principal in the balance with the next lowest APR, and so on, until the full Minimum Payment Due has been applied. If you pay more than the Minimum Payment Due, we'll apply the amount over the Minimum Payment Due first to the balance with the highest APR, then to the balance with the next highest APR, and so on, except as otherwise required by applicable law.

This amends your Card Agreement. Please keep this information for future reference.

Please be sure to pay on time. If you submit your payment by mail, we suggest you mail it no later than 05/31/2024 to allow enough time for regular mail to reach us.
