I understand that upon receiving a copy of this transfer instruction, Transferor will cancel all open orders for my account.

I affirm that I have destroyed or returned to the Transferor all credit/debit cards and/or unused checks issued to me in connection with my account.

If this TD Ameritrade account is a qualified retirement account, I have amended the applicable plan to designate the successor custodian.
