IMPORTANT—READ CAREFULLY

DO NOT DISCARD THIS STATEMENT. It must be submitted whenever further inquiry is made of the Health Department regarding this birth; another fee will be charged unless this statement accompanies a request for further information.

In order to make a proper search for a birth record, full information regarding the birth must be furnished. This includes name, date of birth, father's full name, mother's full maiden name, and the exact address of birth (street and house number or name of hospital). The exact place of birth is particularly important since the Bureau of Vital Records and Statistics indexes births according to the addresses where the births occurred. This acts as a cross check on the name files.

If complete and accurate information was supplied at the time the request for the search was made, this statement means that the doctor or midwife neglected to record this birth with the Department of Health. If the information furnished was not complete, a research will be made without additional charge upon return of this statement to the office in the borough in which you were born with complete and accurate information.

If, after all the possible information has been supplied, the birth record is not found on file, the law provides for registration of the birth at the present time. To eliminate fraudulent applications and to make certain that those records which are accepted are of utmost value to the person concerned, the requirements for filing a birth certificate years after the birth occurred, are stringent.
