Verizon Wireless' Surcharges

Limiting Notations On Payments

Electronic Fund Transfer (EFT)

Your check authorizes us either to make a one-time electronic funds transfer (EFT) from your account or process as a check. If payment is returned unpaid, you authorized us to collect an additional \$25 fee through EFT from your account.

Attention Georgia Customers

Georgia State and Local Sales Taxes are charged only on the monthly access fee and all vertical services for Special Features, including, but not limited to, Call Waiting, Call Forwarding, and Three-Way Calling. If you have a service plan which includes airtime with the monthly access fee, the amount of access subject to Georgia taxes is the lesser of the access charge or \$20.00.

FUSC Change

The Federal Universal Service Charge (FUSC) is a Verizon Wireless charge that is subject to change each calendar quarter based on contribution rates prescribed by the FCC. On January 1, the FUSC decreased to 3.79 percent of assessable wireless charges, other than separately billed interstate and international telecom charges. Notice Of Administrative Charge Decrease

Effective January 1, 2013, the monthly Verizon Wireless Administrative Charge for voice and email plans decreased from \$0.99 to \$0.90 per line for all eligible customers.
