Effective March 1, 2012, the following in-state local toll Operator Assistance rates will increase as follows: Automated Collect dialed 1-800CALLATT - \$.80/minute for the NY Metro, \$1/minute for non-NY Metro, and \$1.20/minute for in-state long distance calling. Continue to mail your payment as usual until you see "Automatic Pay" printed in the Amount enclosed space on your AT&T statement. Either party may terminate this agreement at any time by giving the other party written notice reasonably in advance of the date of termination or any scheduled settlement date. Termination shall not prevent a debit transaction authorized before any notice of termination.
