**RE: Dept of Buildings Local Law 152 Gas Pipe Inspection Updates**

The Dept of Buildings (DOB) is adding fees of up to \$480 for filing Local Law 152 gas pipe deadline extensions, corrections, and "no gas" filings.

Separately, after years of limited enforcement, the DOB has started levying onerous **\$1,500–\$5,000 penalties** for buildings that were due to comply in 2024 (Cycle 2). Clearing the violation requires: 1. Paying the penalty AND 2. Having a licensed master plumber (LMP) perform and file the inspection.

DOB has also issued Notices of Deficiency (NODs) for buildings that had to comply in Cycle 1 (due years 2021-2023). NODs stay open until you've: completed the filing OR the challenge is filed and approved.

Implemented in 2020, Local Law 152 requires most NYC buildings to undergo a gas piping inspection by a LMP every four years with fines upwards of \$5,000 for noncompliance. If you've received this letter, your building likely needs to comply. According to our records, the following building(s) may fall under LL152, due December 31, 2026:

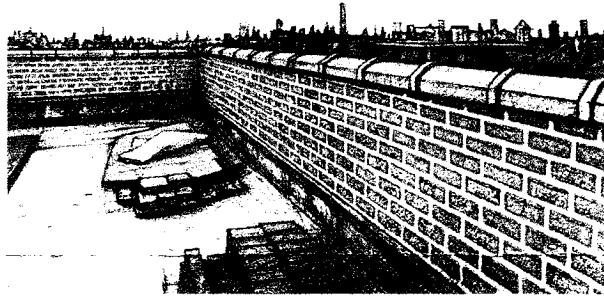

P.S. Local Law 126 requires annual parapet inspections; see reverse side from ReDocs.

**Per NYC's Local Law 126**, all buildings with parapet walls (the part of any wall entirely above the roof line - 1 RCNY 103-15) are required to assess and report on the condition of their rooftop parapet walls by December 31 of each year.

Failure to provide a report upon request by Dept of Buildings can result in substantial violations and/or fines.
