Good Morning Claudio,

We are in the process of warping the first of two creel loads of this yarn. We are experiencing excessive shell offs and have 2 boxes so far. Unfortunately this puts us in a bind for the second creel load as we only received an extra 16 packages. Doug reports in order to do a second creel load, we need 3 boxes (20 count) to complete your order.

Please advise when we can get this additional yarn. In fact, if we continue to have this problem, you may consider four more boxes to be on the safe side.
